CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLARENCE MOSER

of Route 1, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Abiqua Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 15913 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 5, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.31 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ and SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.5 acres in the SE $\frac{1}{2}$ NE $\frac{1}{4}$
15.0 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 24
T. 6 S., R. 1 W., W. M

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 20 chains South of the corner of Sections 18 and 19, in T. 6 S. of R. 1 E. and Section 13 and 24 in T. 6 S. R. 1 W. of the W. M. in Marion County, Oregon, and running thence South 68° East 30 links; thence South 8° 30' West 43.84 chains to a fir stump; thence South 86° West 1.10 chains; thence South 63° 30' West 6.30 chains thence South 84° 30' West 2.45 chains; thence North 65° 45' West 4.50 chains; thence North 1° 34' West 4.47 chains; thence North 21° 45' East 45.07 chains to the East line of W. W. Sanders land; thence South 68° East 4.70 chains to the place of beginning; containing 46.15 acres, more or less situated in Richard Stout Donation Land Claim, in Section 24, Township 6 South, Range 1 West of the Willamette Meridian in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
