CERTIFICATE OF WATER RIGHT

This Is to Certify, That BEN AEBI

of Dayton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Palmer Creek, a tributary of South Yamhill River for the purpose of irrigation under Permit No. 15969 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 11, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.188 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Francis Holdridge D.L.C. No. 56, Section 30, Township 4 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.1 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Francis Holdridge D.L.C. No. 56
4.5 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Francis Holdridge D.L.C. No. 56
4.5 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Francis Holdridge D.L.C. No. 56
1.9 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Francis Holdridge D.L.C. No. 56
Section 30

T. 4 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Being a part of the Francis Holdridge D.L.C. Notification #1022 Claim #56 in Sections 19 and 30 in Tp. 4 S., R. 3 W., of the Will. Mer. Oregon, and beginning at point on the South line of said Claim in the center of the Lafayette-Salem County road said point being S. 89° 30' W. 34.48 chains from the Northeast corner of the Thomas L. Turner D.L.C. Thence N. 7° 50' W. along center of said road 4.20 chains. Thence N. 88° 30' E. 21.33 chains; Thence North 26.69 chains to the North line of said Holdridge Claim. Thence West along North line of Claim 44.41 chains to the most northerly Northwest corner of said Claim. Thence south 31.80 chains to the South line of said Claim. Thence N. 89° 30' E. along South line of Claim and center of County road 23.11 chains to beginning and containing 130.50 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
