## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That A. P. DUDA

, has made proof State of Oregon of Route 1. Mt. Angel to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River

a tributary of Molalla River for the purpose of

irrigation of the State Engineer, and that said right to the use of said waters under Permit No. 15981 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.64 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 NW1, as projected on Bluford Miller D.L.C., Section 16, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres in the  $NE_4^1$   $NW_4^1$ , as projected on Bluford Miller D. L. C. 8.0 acres in the  $NW_4^1$   $NW_4^2$ , as projected on Bluford Miller D. L. C. 21.6 acres in the  $SW_4^1$   $NW_4^1$ , as projected on Bluford Miller D. L. C.

15.6 acres in the SE4 NW4, as projected on Bluford Miller D. L. C. Section 16

4.4 acres in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Bluford Miller D. L. C. Section 17

T. 6 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the quarter section corner on the North side of Section 16, Township 6 South, Range 1 West of the Willamette Meridian in Marion County, Oregon; thence South 7' E. 40.22 chains to the center of Section 16; thence North 89° 10' West 30.00 chains to the center of Pudding River; thence down the center of said stream North 10° East 1.80 chains; thence North 31° West 1.00 chains; thence South 87° West 2.30 chains; thence South 77° West 6.80 chains; thence North 60° West 7.60 chains; thence North 32° 30° West 7.70 chains; thence North 51° 30' East 3.50 chains; thence South 64° 30' East 7.70 chains; thence North 89° East 3.00 chains; thence North 38° East 1.70 chains; thence North 12° 15' East 8.70 chains; thence North 19° 15' West 94 links; thence leaving said river and running North 54° 51' East 26.13 chains to an iron bar; thence North 45° 45' East 4.08 chains to an iron bar in the center of the County Road; thence North 60° 3' West along the center of said road 2.25 chains to an iron bar; thence South 89° 18' East along the North line of Section 16 to the point of beginning, and being situated in Sections 16 and 17 in Township 6 South, Range 1 West of the Willamette Meridian in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
