## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That MURRELL R. BENNETT

of Rt. 2, Box 509, Beaverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Tualatin River

for the purpose of

irrigation
under Permit No. 16029 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from October 19, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.009 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, as projected on Lawrence Hall D.L.C. No. 15, Section 1, Township 1 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre in the  $SW_{4}^{1}$   $SW_{4}^{2}$ , as projected on Lawrence Hall D.L.C. No. 45 0.1 acre in the  $SE_{4}^{1}$   $SW_{2}^{1}$ , as projected on Lawrence Hall D.L.C. No. 45 Section 4

T. 1 S., R. 1 W., W. N.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: That part of the Lawrence Hall Donation Land Claim No. 43 in Township one South of Range one West of the Willamette Meridian, described as follows, to-wit: Beginning at an iron pipe at the northwest corner of tract of land conveyed by John H. McLeod and wife to Nathan C. Rushing and wife by deed recorded in deed book 168, page 617, records of Washington County, Oregon; thence north 23° 38' east 266.4 feet to a point which is the southwest corner of tract of land conveyed by said McLeod and wife to Eila Marsh by deed recorded in deed book 160, page 494, said records; thence north 81° 40° east along the south line of the said Eila Marsh tract 540.5 feet to a point in the center of county road, said point being the southeast corner of the said Eila Marsh tract; thence south 35° 08' East along the center of the county road 253.4 feet to an iron pipe, said point being the northeast corner of the said Nathan C. Rushing tract; thence south 81° 40' West along the north line of the said Nathan C. Rushing tract a distance of 796.0 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
