CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. L. McCALL

of Rt. 1. Box 91, Stayton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed slough a tributary of North Santiam River for the purpose of irrigation under Permit No. 16037 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 25, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.144 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on David Mulkey D.L.C. No. 47, Section 16, Township 9 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.5 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on David Mulkey D.L.C. No. 47
Section 16
T. 9 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the SE corner of the DLC. of David Mulkey and wife, it being Claim No. 47 in the SE $\frac{1}{4}$ of Section 16, T. 9 S., R. 1 East of the W.M. in Marion County State of Oregon, and running thence S. 86° 39' W. 56.07 chains, thence N. 3° 21' W. 42.80 chains to a stake, thence N. 86° 39' E. 50.07 chains to a stake on the E. boundary of said claim, thence S. 3° 21' E. 42.80 chains to the place of beginning containing 240 acres of land save and except therefrom 100 acres heretofore sold and deeded to N. Wade from off the W. side of said described premises and also a right of way leading thereto deeded to Daniel Shaffer and the public, leaving 140 acres conveyed by this instrument of writing, less said right of way.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
