CERTIFICATE OF WATER RIGHT

This Is to Certify, That MYRON B. EATON

of 136 Hansen Lane, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring a tributary of Siuslaw River for the purpose of domestic use for one family and irrigation under Permit No. 16151 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 18, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, being 0.01 cubic foot per second for domestic use and 0.01 cubic foot per second for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7, Section 2, Township 18 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.25 acre in Lot 3 0.50 acre in Lot 7 and domestic Section 2 T. 18 S., R. 10 W., W. H.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point on the westerly line of the County Road 20 feet southeasterly from the north line of lot 7, section 2, township 18 south, Range 10 west of W.M., thence southeasterly along the edge of said county road 170 feet, thence southwesterly at right angles to said road to the Siuslaw River, thence Northwesterly along said river to the southwest corner of that certain tract conveyed to Myron B. Eaton by Deed recorded Dec. 19, 1939, at page 399 of Vol. 197 Lane County, Oregon Deed Records and thence northeasterly to the place of beginning, in Lane County, Oregon.

Beginning at a point on the bank of the Siuslaw River at the northwest corner of Lot 7 in Section 2, township 18 South Range 10 West of the Willamette Meridiam, thence east along the north line of said lot 7, 232 feet more or less to the westerly line of the county road, thence southeasterly along said road 20 feet, thence sw at right angles 164 feet more or less to the bank of the Siuslaw River and thence northwesterly along the said bank 160 ft. to the place of beginning in Lane County, Oregon.

Also an easement for a roadway feet wide so located as to conveniently provide access to the property from the County Road.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
