that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SW 1_4 SW 1_4), Section 8, Township 8 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre,

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point on the south boundary of the Siletz River Highway that is one thousand six hundred ninety-nine and three tenths feet east and ninety and nine tenths feet north of the north corner of sections seventeen and eighteen, township eight south of range ten west of the Willamette Meridian; running thence easterly along the south boundary of highway five hundred twenty-eight and five tenths feet to the west boundary of the Walter Kolbe property; thence south along the Koble property fifty feet to the north bank of the Siletz River; thence southwesterly along the Siletz River to the mouth of a small creek which is south 13° 18' east two hundred fifty-five feet from the place of beginning; thence up center of said creek to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
