## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That H. H. JESSOP

of Rt. 10, Box 789, Milwaukie , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River

for the purpose of

irrigation under Permit No. 16301 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 9, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.005 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_{\frac{1}{4}}$  NW $\frac{1}{4}$ , as projected on Stephan H. Walker D.L.C. No. 52, Section 13, Township 2 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

O.h acre in the SW1 NW1, as projected on Stephan H. Walker D.L.C. No. 52 Section 13 T. 2 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Being a part of the S. H. Walker D.L.C. No. 52 in T. 2 S.R. 1 E. of the W.M., Clackamas County, Oregon, bounded and described as follows to-wit: Beginning at an iron pipe driven at a point which is south 37° 40' east 159.34 feet distant from a point which is south 66° 52' west 1780.98 feet distant from a point which is 751.1 feet south and 201.3 feet east of the quarter section corner between Sections 12 and 13, T. 2 S. R. 1 E. of the W.M.; running thence south 37° 40' east 62.03 feet to a point of curve; thence on a curve to the right, having a radius of 11.0 feet; through a central angle of 75° 01' a distance of 18.24 feet; thence south 58° 13' west 304.91 feet to a point on the meander line of the right bank of the Willamette River at mean low water stage; thence tracing the meander line of the right bank of the Willamette River at mean low water stage north 15° 53' west 94.65 feet to an iron pipe; thence north 61° 20' East 332.85 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
