CERTIFICATE OF WATER RIGHT

of Route 1. Jefferson , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Santiam River a tributary of Willamette River for the purpose of

and satisfies to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

Nay 8, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.325 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 NW $_4^1$, as projected on Reason Roby D.L.C. No. 48, Section 29, Township 9 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

22.2 acres in the SE_{4}^{1} NW_{4}^{1} , as projected on Reason Roby D.L.C. No. 48 3.8 acres in the SW_{4}^{1} NW_{4}^{1} , as projected on Reason Roby D.L.C. No. 48 Section 29

T. 9 S., R. 3 W., W. M.
Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point on the east line of the Donation Land Claim of the Reason Roby 12.60 chains West and 7.51 chains south from the southeast corner of the Donation Land Claim of Joseph Bashaw in township 9 South range 3 West of the Willamette Meridian, Marion County, Oregon; thence west 24.185 chains parallel to the south line of the Joseph Bashaw Claim; thence south 13.38 chains; thence west 6.255 chains; thence south 36.81 chains to the south line of the Donation land Claim of Reason Roby; thence north 23 degrees 30 minutes east 6.23 chains to an angle of said Claim; thence North 48 degrees 30 minutes east 18.00 chains to an angle in the south boundary of the Reason Roby Claim; thence north 70 degrees east 7.00 chains to an angle in said claim; thence south 79 degrees east 8.05 chains to the southeast corner of the Reason Roby Claim; thence North 31.70 chains to the place of beginning and containing 100.35 acres of land.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
