CERTIFICATE OF WATER RIGHT

This Is to Certify, That MICHAEL PETRI

of Rt. 16, Box 187th Milwaukie 2, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring a tributary of Little Kellogg Creek for the purpose of domestic use for two families under Permit No. 16353 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Orin Kellogg D.L.C. No. 55, Section 6, Township 2 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic in SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Orin Kellogg D.L.C. No. 55
Section 6

T. 2 S., R. 2 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Part of Lot One (1) in Block Eight (8) ALDER CREST ACRES, according to the duly recorded plat thereof, and part of the Orrin Kellogg D.L.C. in Section 6, T. 2 S., R. 2 E. W.M., described as: Beginning at the northwest corner of Lot 1 Block 8 Alder Crest Acres, according to the duly recorded plat thereof; thence south along the west line of said Lot 1, a distance of 157.00 feet; thence east parallel with the north line of Lot 1 Block 8 aforesaid, a distance of 276.00 feet, more or less to the east line of a tract of land in the Orrin Kellogg D.L.C. conveyed to John Wesley Paxton by deed recorded Mar. 27th, 1935 in book 226 at page 542, records of Clackamas County, Oregon; thence north along the east line of said John Wesley Paxton land, and along the east line of Lot 1 Block 8 Alder Crest Acres, 157.00 feet, to the northeast corner of Lot 1 Block 8, Alder Crest Acres; thence west on the north line of said Lot 1, a distance of 285.00 feet, more or less, to the place of beginning.

Situate in Clackamas County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
