CERTIFICATE OF WATER RIGHT

This Is to Certify, That NEIL VERBECK

of Route 1, Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Powers Creek a tributary of Abiqua Creek, a tributary of Pudding River for the purpose of irrigation under Permit No. 16485 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 1, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.088 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Daniel B. Markham D.L.C., Section 33, Township 6 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.0 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Daniel B. Markham D. L. C.
Section 33
T. 6 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: That portion of the Daniel Markham Donation Land Claim Certificate #3918, notification #5873 located in sections 33 and 34 Township 6 South Range 1 East of the Willamette Meridian, described as follows: Beginning at a point in the west line of said claim 39.65 chains south of the Northwest corner thereof; thence south along said west line 40.35 chains to the southwest corner thereof; thence east along the south line thereof 20 chains; thence north seven degrees East 18.50 chains; thence South 86 degrees east 6.80 chains; thence north 2 degrees 15 minutes west 22.78 chains; thence west 28.80 chains to the place of beginning and containing 104.20 acres and being in Marion County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
