CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAGLE BROS.

of Star Route #2, Foster , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Ralston Creek a tributary of Santiam River for the purpose of

irrigation and domestic use for one family under Permit No. 16523 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

confirmed dates from August 17, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.085 cubic foot per second, being 0.075 cubic foot per second for irrigation and 0.01 cubic foot per second for domestic use,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SW SW Section 25, Cownship 13 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—ightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre and domestic in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 25 T. 13 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Southeast corner of the Northwest quarter of Section 25 in Township 13 South, Range 1 East of the Willamette Meridian, Oregon; thence running North and parallel with the East boundary line of said Section 25 one hundred fifty five (155) rods; thence running Southwesterly to a point on the West boundary line of Section 25, ninety two (92) rods North of the Southwest corner of the Northwest quarter of said Section 25; thence running South ninety two (92) rods to the Southwest corner of the Northwest quarter of said Section 25; thence running East and parallel with the North boundary line of said Section 25 one hundred sixty (160) rods to the place of beginning, containing 1232 acre more or 125s. Also, beginning at a point which is sixty six (66) rods East of the Southwest Former of the Northwest Quarter of Section 25 in Township 13 South, Range 1 East of the Willamette Meridian, Oregon; thence running West forty six (46) rods; thence running Southeasterly twenty eight (28) rods to a point one rod West of Ralston Creek; thence running Northeasterly twenty eight (28) rods more or less to the place of beginning, containing 3 acres. Save and except the Santiam Road Right-a-wav and also 26 acres reserved by the Grantors and described as follows to-wit: Begin: 'ng at a point which is North one hundred fifty-five (155) rods from the Southeast corner of the Northwest quarter of Section 25 in Township 13 South, Range 1 East of the Willamette Meredian, Oregon, thence running South 68° 30' West 21.69 chains; thence South 11.87 chains to the center of the Santiam Highway; thence North 71° 30' East along center of said Highway 20.95 chains to the East boundary line of the Northwest Quarter of said Section 25; thence North 12.97 chains to the place of beginning. Also, save and except a parcel of land lying in the Northwest quarter (NW1) of Section 25, Twp. 13 South, Range 1 East, W.M., Linn County, Oregon and being a portion of the following described property; That tract of land which was conveyed by that certain deed to Roy C. Fisher and Adda A. Fisher, recorded in Book 1111, Page 301 of Linn County Record of Deeds. The said parcel being described as follows:

Beginning at a point on the center line of the Santiam Highway at Engineer's Station 1053 • 49.65 said point also being 1157 feet North and 1313 feet East of the quarter section corner between Sections 25 and 26 in Twp. 13 South, Range 1 East, W.M.; thence along the arc of a 716.3 foot radius curve to the right (the long chord of which bears North 57° C6' East, 344.44 feet) a distance of 347.71 feet; thence North 71° O1' East along the center line of the said highway a distance of 315.25 feet to Engineer's Station 1060 + 12.65; thence South 18° 59' East a distance of 280 feet; thence South 71° O1' West a distance of 210 feet; thence South 18° 59' East a distance of 222 feet; thence 70° 50' West a distance of 278.21 feet; thence North 40° O0' West a distance of 150 feet to the point of beginning.

The parcel of land to which this description applies contains 5.hh acres, of which 0.h7 acres lies within the existing right-of-way, title to which hereby is acknowledged to be in the public, and 4.97 acres lie outside of the existing right-of-way.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
