## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That FRANCIS A. BUCKLEY

State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a tributary of Willamette River

for the purpose of

irrigation under Permit No. 16566 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 4, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SEL, as projected on Flores Fullquarts D.L.C. No. 71, Section 35, Township 3 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the arrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 3.4 acres in the  $NE_4^1$  SW<sub>4</sub>, as projected on Flores Fullquarts D.L.C. No. 71
- 0.7 acre in the  $SE_4^2$   $SW_4^2$ , as projected on Flores Fullquarts D.L.C. No. 71 8.2 acres in the  $NW_4^2$   $SE_4^2$ , as projected on Flores Fullquarts D.L.C. No. 71 1.7 acres in the  $SW_4^2$   $SE_4^2$ , as projected on Flores Fullquarts D.L.C. No. 71 Section 35

T. 3 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: ALSO the following premises: All of Lots One, Two and Three of the following described premises: Situate, lying and being in the County of Yamhill and State of Oregon and being a part of the original D.L.C. of Flores Fullquarts, Claim No. 71 and 73 in T. 3 and 4 South, Range 3 West of Willamette Meridian in said County, the part hereby conveyed being bounded and particularly described as: Beginning at a point which is 20.15 chains South of the Northwest corner of said claim, and running thence East 40.45 chains to a stake in angle of county road; thence north 20.38 chains to an iron pin at the northeast corner of lands deeded to the said Henry Ecks and Chris Ecks by Maria A. Rossner and husband; thence west along north line of said claim 13.60 chains to center of County road; thence south 28° 08' west along center of said road 6.43 chains; thence south 48° 30' west along center of said road 11.70 chains; thence west along private road 14.90 chains to west line of said claim; thence south 6.95 chains to the place of beginning and containing 53 acres of land, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
