## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That O. K. BROCK

of Box 215, Willamina , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamina Creek

has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 27, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.105 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot h (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ) and SE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Jeremiah Lamson D.L.C. No. 46, Section 36, Township 5 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.4 acres in Lot 4 ( $NE_{\frac{1}{4}}^{1}SW_{\frac{1}{4}}^{1}$ )

0.6 acre in the  $NE_4^1$  SW $_4^2$ , as projected on Jeremiah Lamson D.L.C. No. 46 5.4 acres in the  $SE_4^1$  SW $_4^2$ , as projected on Jeremiah Lamson D.L.C. No. 46 Section 36

T. 5 S., R. 7 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Tract No. 1 in Corbett Acreage in Yamhill County Oregon. as the same is now platted and on file in the office of the County Clerk of said county. Also the following described premises to-wit Bounded on the east by land deeded Andrew Kershaw and land deeded to Facific Face Brick Company, bounded on the north by land deeded to Dan Savage bounded onthe south and west by center of County road being a part of the Jeremiah Lamson donation land claim situated in section 36 Township 5 south Range 7 West of the Willamette Meridian in the County of Yamhill State of Oregon containing ten acres more or less.

Saving and excepting therefrom Two acres more or less deeded by Smiley Carter and Wife to Joseph C Henry and Wary A. Henry on April 23rd 1910 by deed recorded May 20th 1910 in Book 58 at page 343 Deed Seconds of Yamhill County Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
