## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That T. W. ALLEN

of Canyonville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River

a tributary of Umpqua River irrigation

for the purpose of

under Permit No. 16843 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 12, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.125 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET SWT, as projected on Charles W. Beckworth D.L.C. No. 39, Section 8, Township 30 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.2 acres in the  $SE_{4}^{1}$   $SW_{4}^{1}$ , as projected on Andrew Chapman D.L.C. No. 43 4.8 acres in the  $NE_{4}^{1}$   $SW_{4}^{1}$ , as projected on Andrew Chapman D.L.C. No. 43 Section 8

T. 30 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Northeast Corner of Donation Land Claim No. 43 in Township Thirty South, Range Four, West of the Willamette Meridian, thence South along the East line of said claim 28 chains, thence West 20 chains, to the West boundary line, thence North 28 chainse to the North west Corner, thence East 20 chains to the place of beginning; All being situated in Sections Eight and Seventeen, Township Thirty South, Range Four West of the Willamette Meridian.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
