CERTIFICATE OF WATER RIGHT

This Is to Certify, That MRS. ESTHER QUEIROLO

of Rt. 1, Box 269, Clackamas , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clackamas River

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 16993 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from May 8, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE_4^1 NW_4^1), Section 13, Township 2 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres in the $NE_{\frac{1}{4}}^{1}$ $NE_{\frac{1}{4}}^{1}$ 10.0 acres in Lot 1 $(NW_{\frac{1}{4}}^{1} NE_{\frac{1}{4}}^{1})$ Section 13

T. 2 S., R. 2 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning 30 feet south of the northeast corner of section thirteen (13) township two (2) south of range two (2) east of the Willamette Meridian, running thence on section line south 5.25 chains; thence west and parallel with the north line of section to the right bank of the Clackamas River; thence following the meander of said river northwesterly down stream to a point 30 feet south of where the line between section 12 and 13 intersects the right bank; thence east parallel with and 30 feet south of said section line to place of beginning, containing 22 acres, more or less, in Clackamas County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
