CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED H. PETERS

of Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Spring Creek, a tributary of Willamette River for the purpose of irrigation under Permit No. 17003 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 13, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Howard Maupin D.L.C. No. 43, Section 35, Township 16 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.3 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Howard Maupin D.L.C. No. 43

6.7 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Howard Maupin D.L.C. No. 43

Section 35

T. 16 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point in the east line of the Howard Maupin Donation Land Claim #43, in township 16 south, Range 4 West, Willamette Meridian, 17.37 chains, north 54' west from the southeast corner thereof, thence west 25.20 chains to the center of the county road, known as the River Road, now the Pacific Highway; thence north 16 degrees 55' west along the center of said road 7.13 chains, thence east 28.44 chains to a point in the east line of said donation land claim #43, 7.13 chains north of the place of beginning; thence south 7.13 chains to the place of beginning, containing 20 acres in Lane County, Oregon, together with all improvements now located thereon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
