CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED D. SCHROEDER

of Route 1, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River

a tributary of Yolalla River

irrigation
under Permit No. 17112 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Or jon; that the priority of the right hereby
confirmed dates from June 24. 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NE_4^{\frac{1}{4}}$ SW $_4^{\frac{1}{4}}$, Section 10, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

18.0 acres in Lot 2 ($SW_{\frac{1}{4}}^{1} NW_{\frac{1}{4}}^{1}$ and $SE_{\frac{1}{4}}^{1} NW_{\frac{1}{4}}^{1}$) Section 10 T. 5 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the N.E. corner of the C. C. Cooley D.L.C. #41 in T. 5 S., R. 1 W. of the Willamette Meridian in Marion County, Oregon, thence West along the North line of said Claim 1.57 chains to an iron pipe; thence North 15' West 3.38 chains to an iron pipe in the center of the N.W. quarter of Section 1C, thence North 89° 45' East 9.47 chains to an iron pipe; thence South 15' East 20.14 chains to an iron pipe in the South line of the N.W. quarter of Section 10: thence South 89° 30' West 15.39 chains to the East line of the C. C. Dooley D.L.C.; thence North 24° 18' East 18.31 chains to the point of beginning, containing 22.78 acres of land, more or less, part of Lot #2 in Section 10 T. 5 S., R. 1 W., Marion County, Oregon. Save and except a strip of land 20 feet wide along the South end of the above described premises.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
