CERTIFICATE OF WATER RIGHT

This Is to Certify, That KENNETH YODER

of Route 1, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of Molalla River for the purpose of irrigation under Permit No. 17363 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 25, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 10, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
3.0 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 10
T. 5 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Northwest corner of the land described in the Patent to Ezekiel Hendryx, recorded April 3, 1894 in Vol. 58, Page 88 Deed Records for Marion County, Oregon; running thence South along the West line of said claim to the bank of Pudding River; thence Easterly along the Northerly bank of Pudding River to the North line of the Hendryx claim, which point is 30.75 chains more or less, Easterly from the place of beginning; thence Westerly along the North line of the Hendryx claim to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
