This Is to Certify, That O. C. BEALS

of Route 1, Shericar , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River a tributary of for the purpose of Yamhill River

irrigation under Permit No. of the State Engineer, and that said right to the use of said waters 17433 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 11, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.212 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 33, Township 5 South, Range 6 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the prope. state officer, A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in Lot 5 (SW NE)

5.7 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Solomon Eads D.L.C. No. $3\hat{v}$ 2.7 acres in Lot 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)

2.8 acres in the NN 554, as projected on Solomon Eads D.L.C. No. 38

4.8 acres in Lot 6 (NW SE)

Section 33 T. 5 S., R. 6 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a stone set South 5° East 8.69 chains from the Northwest corner of the Donation Land Claim of Solomon Eads, Notification No. 5051, Claim No. 38 in T. 5 S., R. 6 West of the Willamette Meridian in Yamhill County, Oregon and running thence South 5° East 5.10 chains; thence North 75° East 20 chains; thence North 5° West 5.10 chains; thence North 75° East 8.80 chains; thence North 42. West 12.24 chains to the South line of the John P. Wood Donation Land Claim No. bh in said Township and Range; thence Sorth 75° West 28.80 chains; thence South 5° East 12.24 chains to the place of beginning, containing 44.50 acres, more or less.
