**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** JOHN E. SCOFIELD

of Charleton Street, Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of North Santiam River for the purpose of irrigation under Permit No. 17573 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 26, 1917

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.275 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NW $\frac{1}{4}$  and SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Moses Edgar D.L.C., Section 25, Township 9 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.0 acres in the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Moses Edgar D. L. C.  
9.0 acres in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Moses Edgar D. L. C.

T. 9 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at Point 30.43 chains West of the North East corner of the Donation Land claim of Moses Edgar and wife in Township 9 South range 2 West of the Willamette Meridian in Marion County Oregon thence South 29.64 chains more or less to the Division line between the north and South Halves of said Claim thence East along Said Division lines 10 chains more or less to the East line of the land conveyed to C. F. Scofield and wife by Deed recorded January 29, 1915 in Vol. 135, Page 200, Marion County Deed Records thence North along the East line of said Scofield tract 29.64 chains more or less to the north line of Said Moses Edgar donation land claim thence West along the north line of Said Donation Lane (Land) claim 10 chains more or less to the Place of Beginning. Situated in the County of Marion and State of Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
