CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. R. MORRIS AND LETHA MORRIS

ofRoute 2, Box 87, Wolalla , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Nate Creek, tributary of Milk Creek, and Milk Creek attibutary of Molalla River

for the purpose of

irrigation under Permit No. 14478 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 9, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second, being 0.125 cubic foot per second from Nate Creek and 0.025 cubic foot per second from Milk Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 ($NE_{\frac{1}{4}}$ $NE_{\frac{1}{4}}$) and Lot 2 ($NW_{\frac{1}{4}}$ $NE_{\frac{1}{4}}$), Section 6, Township 5 South, Range 3 East, W. W.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.5 acres in Lot 1 (NE 1/2 NE 1/4) 8.5 acres in Lot 2 (NW 1/4 NE 1/4) Section 6 T. 5 S., R. 3 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: The North half of the Northeast quarter of Section 6 T. 5 S. R. 3 E of the W.M., in the county of Clackamas and State of Oregon, Except that part conveyed to School District #3 by deed recorded in book lh2, page 216, and also Except that part in roads.

• The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
