CERTIFICATE OF WATER RIGHT

This Is to Certify, That Alfred G. Scheidler

of Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Silver Creek a tributary of Pudding River for the purpose of

irrigation under Permit No. 14560 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 21, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.73 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4^1 NE_4^1 , SW_4^1 NW_4^1 and SE_4^1 NW_4^1 , as projected on Samuel Cox D.L.C. No. 45, Section 33, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.3 acres in the SW1 NE1, as projected on Samuel Cox D.L.C. No. 45 14.4 acres in the NE1 NE2, as projected on Elias Cox D.L.C. No. 43 10.5 acres in the SW1 NW2, as projected on Samuel Cox D.L.C. No. 45

10.5 acres in the SW NW1, as projected on Samuel Cox D.L.C. No. 45 lu.9 acres in the SE1 NW1, as projected on Samuel Cox D.L.C. No. 45 l3.1 acres in the SE1 NW1, as projected on Elias Cox D.L.C. No. 43

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows:

Beginning at a point in the South boundary line of the Elias Cox and wife Donation Land Claim in Township 6 South, Range 1 West of the Willamette Meridian, said beginning point being North 88° 21' West 27.17 chains distant from the Southeast corner of said Donation Land Claim; thence North 2° 12' East 22.20 chains; thence North 2° 36' East 3.86 chains to a point in the South line of the Silverton and Salem County Road; thence North 87° 24' West 4.22 1/4 chains to the Northeast corner of a 30 x 50 foot piece of land deeded by Jennings Smith and wife to the P. R. L. & P. Co., a corporation, on March 8, 1917, by deed recorded in Vol. 142, Page 530, Deed Records for Marion County, Oregon; thence South 2° 36' West 30 feet; thence North 87° 24' West 75.00 feet to the East line of School House Lot; thence South 2° 30' West 3.21 chains; thence South 2° 15' West 22.40 chains to a point in aforesaid South boundary of claim; thence South 88° 21' East 5.30 chains to the beginning, and being situated in Marion County, Oregon.

Also: Lot Ten (10) and the West one-half of Lot Eleven (11) South in the Town of Bethany (now vacated) in Marion County, Oregon.

Also: Commencing at a point in the South boundary line of the Elias Cox and wife

Donation Land Claim in Township 6 South, Range 1 West of the Willamette Meridian in Marion County, Oregon; said commencing point being North 88° 21' West 21.61 chains distant from the Southeast corner of said Donation Land Claim; and is marked by a stone 12" x 13½" on face and set 16 inches deep 28 inches North of the corner; thence North 2° 12' East 26.00 chains to a point in the South side of the Silverton-Salem road, this corner is also marked by a stone 12 by 1h inches and set 1h inches deep; thence North 87° 2h' West 1.765 chains; thence South 2° 36' West 3.86 chains; thence North 87° 2h' West 3.785 chains; thence South 2° 12' West 22.20 chains to a point in the aforesaid South boundary; thence South 88° 21' East 5.57 chains to the beginning, situate in Marion County, Oregon.

Also: That portion of the Samuel S. Cox and wife Donation Land Claim No. 45 lying with-in Section 33, Township 6 South, Range 1 West of the Willamette Meridian in Marion County, Oregon, described as follows: Beginning at the Northwest corner of said Claim No. 45; thence along the North line thereof South 88° 21' East 57.10 chains to the Northeast corner of said Claim; thence South & ang the East line thereof 5.62 chains; thence West 57.07 chains to a point on the West line of said claim 1.35 chains North of the West quarter corner of said Section 33; thence along the west line of said Claim No. 45 North 0° 38' West 7.34 chains to the place of beginning.

Also: Beginning at a point 5.62 chains South and 8.50 chains West of the Northeast corner of said Claim No. 45, said point being in the South line of the above described tract; thence along said South line West 28.57 chains to a point which is 20.00 chains East of the West line of said Section 33; thence South 5.50 chains; thence North 82° 31' East 28.82 chains; thence North 1.75 chains to the place of beginning and being situated in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
