that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.34 cubic i oot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SWA SEA, as projected on Chas. E. Fendall D.L.C.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to the state of one cubic foot per second acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be limited still further to a total diversion of not to exceed 0.34 cubic foot per second.

Also beginning at the Northwest Corner of the Charles E. Fendall and Wife's Donation Land Claim in Township 5 South of range 7 West of the Willamette Meridian, in Yamhill County, Oregon; thence South 332 West 18.00 chains to a stake; thence South 69° East 56.50 chains to intersect the West line of L. Booth's land at a stake on the West bank of Willamina Creek; thence in a Northeasterly course with meanderings of said creek and with the West line of L. Booth's land till it intersects the Northern boundary line of Charles E. Fendall and Wife, Donation Land Claim at the Northwest Corner of that part of said Donation Land Claim sold to L. Booth by Charles E. Fendall and Wife; thence North 69° West with the Northern boundary of said Donation Land Claim 59.50 chains to the place of beginning, containing 100 acres, more or less, in Yamhill County, State of Oregon, containing one hundred Eighty Acres (180) Acres, more or less.

Subject, however, to all existing right-of-way and to all exceptions conditions or limitations expressed in Government patents or in deeds now of record.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
