## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That ARTHUR R. AND VESTA BUYSERIE

of Route 1, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Champoeg Creek irrigation

for the purpose of

under Permit No. 15346 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.195 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The roint of diversion is located in the SE4 SW4, as projected on M. LaForte D.L.C. No. 100, Section 15, Township 4 South, Range 2 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to One-eight eth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.4 acres in the SW1 SW1, as projected on Etienne Pettier D.L.C. No. 92
3.2 acres in the SE1 SW1, as projected on Etienne Pettier D.L.C. No. 92

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Northeast corner of the Hugh Cosgrove Donation Land Claim No. 99 in Township & South, Range 2 West of the Willarette Meridian in Marion County, Oregon; running thence South 11.25 chains; thence West 11.25 chains; thence South 55° East along the Southerly line of the E. Peltier Donation Land Claim No. 92 in Township & South, Range 2 West of the Willamette Meridian in Marion County, Oregon, 30.15 chains to the most Southerly corner of the Peltier Claim; thence North 25° East along the Easterly line of the Peltier Claim, 20.25 chains to the Northeast corner of said claim; thence North 55° West along the Northerly line of said claim, 80.70 chains to a point, thence South 35° West 12.40 chains to the Southerly line of the Peltier Claim; thence South 62° East along the Southerly line of the Peltier Claim, 57.30 chains to the place of beginning, and containing 96 acres of land, more or less in Sections 15, 16 and 22 in Township & South, Range 2 West of the Willamette Meridian in Marion County, Oregon.
