CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is in Certify. That GALLAHER FARM COMPANY, by W. C. Gallaher of Rt. 2, Freewater State of Oregon has a right to the use of the waters of Dugger Creek, a tributary of Pine Creek,

for the purpose of the irrigation of 125.8 acres of land, domestic and stock use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the State No.IRD of the State of Oregon, in Volume 3, at page 321; that the priority of the right hereby confirmed dates from the year 1890 for 25 acres, from 1894 for 12 acres, from 1908 for 19 acres and from 1900 for 69.8 acres;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 1.58 sec. ft. from May 1st to September 1st of each year or its equivalent in case of rotation; the total quantity diverted during each irrigation season not to exceed 377.4 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

8 acres in Northeast quarter of Northeast quarter; 17 acres in Southeast quarter of Northeast quarter; 12 acres in Southeast quarter of Northeast quarter; 4.5 acres in Northeast quarter of Northeast quarter; 11 acres in Southeast quarter of Northeast quarter; 3.5 acres in Southeast quarter of Northeast quarter; 22.5 acres in Southeast quarter of Northeast quarter; 4.3 acres in Southeast quarter of Northeast quarter; 17 acres in Northeast quarter of Southeast quarter; 26 acres in Northeast quarter of Southeast quarter; 26 acres in Northeast quarter of Southeast quarter; Section Twenty-five (25), Township Six (6) North Range Thirty-four (34) East of Willamette Meridian, in Umatilla County, Oregon.

The right to the use of the water afores id hereby confirmed is restricted to the lands or place of use herein described.
