## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That W. G. WOLFE

of Route 2, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek a tributary of Pudding River for the purpose of

irrigation under Permit No. 15523 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 8, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.34 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (SE & SE &), Section 25, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point which is five chains and fifty links West 88° 27' North from the South East corner of the J. Newman D. L. C.; Thence South 10° 20' West two chains eighty one links; thence West 83° 25' North to water line on North side of Butte Creek; thence along water line of Butte Creek in a Westernly direction to its intersection with the Right of Way of the Willamette Valley Southern Railway Co.; thence in a Northeasternly direction along the Right of Way of the Willamette Valley Southern Railway Co. to its intersection with the South line of the J. Newman D. L. C.; thence East 88° 27' South to place of beginning, Containing three acres, more or less, all in the County of Clackamas and State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
