CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY F. MINTEN

of Route #1, Stayton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Santiam River

a tributary of Santiam River

for the purpose of

irrigation and supplemental irrigation under Permit No. 15547 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 17. 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.175 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4^1 SE_4^1 , Section 12 and NV_4 NE_4^1 , Section 13, as projected on John Hause D.L.C. No. 49, Township 9 South, Range 1 Nest, W. K.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shell be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{3}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.7 acres in the SW¹₄ SE¹₄, as projected on John Hause D.L.C. No. 49

2.3 acres in the NW¹₄ NE¹₄, as projected on John Hause D.L.C. No. 49

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Southwest corner of the John Hause Donation Land Claim No. 49, in Township 9 South, Range 1 West of the Willamette Meridian, in Marion County, Oregon; running thence East 10 chains; thence North 18 chains; thence West 10 chains; thence South 18 chains; to the place of beginning and being a part of the John Hause D. L. C. No. 49 in said Township and Range, Marion County, Oregon.

Also, Beginning at a point 18 chains north of the Southwest corner of the John Hause and wife Donation Land Claim in Section 12, Township 9 South, Range 1 West of the Willamette Meridian, being Claim No. 49, Certificate No. 2248, and Notification No. 1094, running thence East 40 rods; thence North 3 rods; thence West 40 rods to the West line of said claim; thence South 3 rods to the place of beginning, containing in all three fourths of one acre.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
