## CERTIFICATE OF WATER RIGHT

This Is to Certify, That DELBERT G. SIKES

of Route 2, Springfield , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Solomon Creek and Camp Creek McKenzie River

under Permit No. 15686 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of . z right hereby confirmed dates from January 10, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.125 cubic foot per second, being 0.225 cubic foot per second from Camp Creek and 0.20 cubic foot per second from Solomon Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NW_2^+$  NE $\frac{1}{4}$  and NE $\frac{1}{2}$  NE $\frac{1}{4}$ , as projected on Wm. McMeekan D.L.C. No. 49; NE $\frac{1}{4}$  NN $\frac{1}{4}$ , as projected on Jas. W. Kesling D.L.C. No. 46; SW $\frac{1}{4}$  NN $\frac{1}{4}$ and SE1 NW1, as projected on Jos. McLean D.L.C. No. 18, Section 8, Township 17 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in the NW1 NE1, as projected on Wm. McLeekan D. L. C. No. 19 1.2 acres in the NE1 NW1, as projected on Wm. McLeekan D. L. C. No. 19 4.2 acres in the NE1 NW1, as projected on Jas. W. Kesling D.L.C. No. 16 3.4 acres in the SW1 NW1, as projected on Jos. NcLean D. L. C. No. 18 17.0 acres in the SE1 NW1, as projected on Jos. McLean D. L. C. No. 18 3.2 acres in the SE4 NW4, as projected on Wm. McMeekan D. L. C. No. 19 Section 8
