CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. R. LIGGETT

of Rt. 2, Box 143, Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of South Fork Santiam River for the purpose of irrigation under Permit No. 15802 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 35, Township 11 South, Range 2 West and Lot 4 (SE $\frac{1}{4}$ NE $\frac{1}{4}$), Section 2, Township 12 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Andrew Kees D.L.C. No. 69

8.2 acres in Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
2.5 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Andrew Kees D.L.C. No. 71
3.0 acres in Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
2.1 acres in Lot 3 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)
5.9 acres in Lot 4 (SE $\frac{1}{4}$ NE $\frac{1}{4}$)

T. 12 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point which is on the south line of the D. L. C. of Andrew Kees & wife, Not. No. 1199 and claims Nos. 69 and 71 lying in T. 11 and 12 S., Range 2 W. of the W. M., Oregon and said point being E. a distance of 645.2 ft. from the NE corner of the D. L. C. of William B. Gore and wife being Not. No. 2297 and Claim No. 38 in said T. 12 S., Range 2 W, thence N. 40.0 feet thence east 1546.0 feet, more or less, parallel with the south line of said Claim No. 71, to the center of a creek, thence South 10° 21' East up the center of said Creek, 40.7 feet to a point on the south line of said Claim No. 71 which is W. a distance of 115.5 feet from the interior angle corner on the S. line of said Claim No. 71, thence South 20° W. to a point which is East a distance of 124.7 feet from the NE corner of James M. Marks Claim Not. No. 2293 and Claim No. 44 in said Township 12 S., Range 2 W. thence W. a distance of 1034.9 feet to a point which is on the North line of and is E. a distance of 1288.9 feet to the south line of said Claim No. 71 thence West 14.8 feet to the place of beginning and containing 39.5 acres, more or less, all lying in Linn County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
