CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. B. CARLIN

of Route 2, Corvallis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaver Creek

a tributary of Muddy Creek, a tributary of Marys River

for the purpose of

under Permit No. 16036 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 24, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Stephen Gates D.L.C. No. 50, Section 10, and Lot 12 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), Section 15, Township 13 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equal lent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.5 acres in Lot 8 (SE $_{4}^{1}$ SE $_{4}^{1}$)
Section 10
10.7 acres in Lot 12 (NE $_{4}^{1}$ NE $_{4}^{1}$)
8.2 acres in Lot 11 (SE $_{4}^{1}$ NE $_{4}^{1}$)

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Southeast corner of the lands conveyed to William Gates by patent recorded Book Q, Page 262, Deed records of Benton County, Oregon, and running thence North 50.859 chains to a 1½" buggy axle; thence North 89° 45' West 13.75 chains to a 1½" buggy axle; thence South l1' East 51.238 chains to a stake which is on the South line of said D.L.C.: thence North 89° 18' East 13.587 chains to a wagon thimble at the place of beginning, containing 69.589 acres in Benton County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
