CERTIFICATE OF WATER RIGHT

This Is to Certify, That

REX GIBSON

of Rt. 1, Box 151, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

an unnamed slough a tributary of Willamette River

for the purpose of

irrigation under Permit No. 16012 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 27, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_3^4 SW $_4^4$, as projected on Jesse Harriot D.L.C. No. 67, Section 15, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.9 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Jesse Marriot D.L.C. No. 67 Section 15

7.9 acres in the NE4 SE4, as projected on Jesse Harriot D.L.C. No. 67 Section 16

T. 7 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at an iron stake at a point in the middle of the County road, which is 25 feet West of the Northwest corner of a Ten acre tract of land owned by L. D. Fields; and running thence Northerly along the center of said road 430 feet; thence East 2,164 feet; thence South 24° 15' East 443 feet; thence West 2,189 feet to the place of beginning, and containing Twenty acres, more or less all being situated in Section 16, Tp 7 South of Range 3 West of the Willamette Meridian in Polk County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
