CERTIFICATE OF WATER RIGHT

This Is to Certify, that florence evans

of Route 1, Hubbard , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of Pudding River irrigation

for the purpose of

under Permit No. 16237 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 21, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 NE4, as projected on Joseph Churchill D.L.C. No. 37, Section 5, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 5.1 acres in the $SE_{\frac{1}{4}}^{\frac{1}{4}}$ SW $_{\frac{1}{4}}^{\frac{1}{4}}$, as projected on Joseph Churchill D.L.C. No. 56 8.6 acres in the SW $_{\frac{1}{4}}^{\frac{1}{4}}$ SE $_{\frac{1}{4}}^{\frac{1}{4}}$, as projected on Joseph Churchill D.L.C. No. 56 Section 32 T. 4 S., R. 1 W., W. M.
- 4.1 acres in the $NE_{\frac{1}{4}}$ $NE_{\frac{1}{4}}$, as projected on Joseph Churchill D.L.C. No. 37 9.9 acres in the $NV_{\frac{1}{4}}$ $NE_{\frac{1}{4}}$, as projected on Joseph Churchill D.L.C. No. 37
- 0.3 acre in the NE4 NW4, as projected on Joseph Churchill D.L.C. No. 37

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at an angle in the South boundry of the Joseph Churchill Donation Land Claim in Section 5, Township 5 South, Range 1 West of the Willamette Meridian, Marion County, Oregon; thence South 89 degrees 52' East 10.685 chains along the South line of said Donation Land Claim to an iron pipe; thence North 30 degrees 50' East 7.325 chains; thence North 66 degrees 19' West 35.965 chains to a plowshare in the center of the County road; thence South 45 degrees 14' West along the center of said road 8.41 chains to a plowshare in the South boundary of said Donation Land Claim; thence South 58 degrees 45' East along the South boundary of said Donation Land Claim 28.417 chains to the place of beginning, containing 35.90 acres of land, more or less, being a part of the Joseph Churchill Donation Land Claim in Townships Four (4) and Five (5), Range one (1) West of the Willamette Meridian in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
