CERTIFICATE OF WATER RIGHT

This Is to Certify, That LLOYD R. AND MILDRED O. SPIRES

of Route 2, Box 145, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Little Luckiamute River a tributary of Luckiamute River for the purpose of irrigation under Permit No. 16238 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 22, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Samuel Gothard D.L.C. No. 48, Section 21, Township 8 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.2 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Samuel Gothard D.L.C. No. 48
1.0 acre in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Samuel Gothard D.L.C. No. 48
19.8 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Samuel Gothard D.L.C. No. 48
Section 21
T. 8 S., R. 6 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Southeast corner of Samuel Gothard Donation Land Claim, Not. No. 5280, Claim No. 48 in Township 8 South, Range 6 West of the Willamette Meridian in Polk County, Oregon; and running thence West 15.38 chains; thence North 50° 15' West 4.65 chains; thence North 3° 30' East to the center of the Little Luckiamute River; thence down the center of said River in a Southeasterly direction to the East boundary line of said Donation Land Claim; and thence South 7° West to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
