CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. G. ROBERTS

of Route 2, McMinnville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork Yamhill River

a tributary of Yamhill River

for the purpose of

irrigation under Permit No. 16340 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 18, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SW\frac{1}{4}SW\frac{1}{4}$, as projected on Henry Bird, D.L.C., Section 11, Township 4 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.8 acres in the $SW_{\frac{1}{4}}$ $NW_{\frac{1}{4}}$, as projected on Miles Carey D.L.C. No. 110.9 acres in the $NW_{\frac{1}{4}}$ $SW_{\frac{1}{4}}$, as projected on Miles Carey D.L.C. No. 1110.3 acre in the $NE_{\frac{1}{4}}$ $SW_{\frac{1}{4}}$, as projected on Miles Carey D.L.C. No. 1110. Section 111

T. 4 S., R. 4 W., W. V. Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point marked by a 3/4" iron pipe at the intersection of the North right of way line of State Highway 99 W and the West right of say line of a roadway, which point is 2473.13 ft. South of and 1172.64 ft. West of the S. W. corner of the Elijah Millican Donation Land Claim No. 43, Notification No. 1230. Thence North 28° 13' 00" West 561.63 ft along the West right of way line of said roadway to a point marked by a 2" iron pipe. Thence South 62° 26' 00" West 366.89 ft along the line common with lot 51 of St. Joe Orchards Homes to a point marked by a 2" iron pipe. Thence North 28° 13' 00" West 555.75 ft. along the line common with said lot 51 to a point marked by a 2" iron pipe Thence South 62° 26' 00" West 391.90 ft along the line common with United States Farm Security Administration Farm unit No. 69. to a point marked by a 2" iron pipe. Thence South 28° 13' 00" East 1706.07 ft. along the line common with the May Mullens property to a point marked by a 2" iron pipe. Thence South 64° 48' 00" East 40.60 ft. along the line common with the May Mullens property to a point marked by a 2" iron pipe on the North right of way line of the State Highway. Thence on a curve to the left with a radius of 686.3 ft. 349.36 ft. along the said State Highway right of way to a point. Thence North 16° 44' 00" East 618.18 ft. along the said State Highway right of way to a point of beginning. Lot No. 51 of St. Joe Orchards Homes.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
