CERTIFICATE OF WATER RIGHT

This Is to Certify, That RAYMOND BUHR

of Route 1, Box 132, Mt. Angel, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Pudding River for the purpose of irrigation under Permit No. 16466 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Samuel Tucker D.L.C. No. 52, Section 16, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.5 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Samuel Tucker D.L.C. No. 52
11.4 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Samuel Tucker D.L.C. No. 52
Section 15
8.0 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Samuel Tucker D.L.C. No. 52
7.1 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Samuel Tucker D.L.C. No. 52
Section 16
T. 6 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing at the quarter Section corner between sections 15 and 16 in township 6 South Range one west Willamette Meridian, thence east on the north boundary of the south half of section 15, Fifteen chains and fifty links; thence north five chains and sixty-two links to near the middle of the county road leading to Parkersville; thence N. 13° 15' West Thirty-three chains and sixty links along the middle of said Road to its intersection with the road leading to Mt. Angel; thence S. 18° twenty-one chains and seventy-five links to the line dividing section 16 into north and south halves; thence east twenty chains and Ninety five links to the beginning and containing 46.04 acres, more or less and situated in Marion County, State of Oregon.

Beginning at the quarter section corner common to section 15 and 16, T. 6, S.R. 1 W. W.M. in Marion County Oregon thence S. 89 degrees 20' E. along the north boundary of S. W. quarter of said section 15, 9.47 chains to the N.E. corner of the tract of land conveyed to Otto Willman by deed recorded in Vol. 226, Page 366, Marion County, Records. Thence South along the East boundary of said tract 14.99 chains; Thence N. 89 degrees 27' W. 15.83 chains to a point on the west Boundary of said tract; thence north 14.985 chains to the N.W. corner of said tract, thence S. 89 degrees 40' E. 6.36 chains to the point of beginning Containing 23.74 acres and being parts of section 15 and 16, T. 6 S. R. 1 W. W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
