CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM H. FERN

of Rickreall, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 16526 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 17, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on David Goff D.L.C. No. 45, Section 31, Township 7 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.6 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on David Goff D.L.C. No. 45
0.4 acre in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on David Goff D.L.C. No. 45
Section 30

T. 7 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Southeast corner of the Donation Land Claim of David Goff and wife, Not. No. 113 Claim No. 45 in Township 7 South Range 4 West of the Willamette Meridian, in the County of Polk and State of Oregon, and running thence North 40.00 chains to the County Road leading from Dalls to Salem, Oregon; thence South 85° 43' West along said road, 3.00 chains to the East boundary of Derry Depot grounds; thence south 14° 30' West 4.90 chains to corner of Depot Grounds; thence South 34° 20' West 4.28 chains; thence South 69° 30' West 2.65 chains to Southwest corner of Depot grounds; thence North 75° 30' West 60 feet to the West line of the Railroad right of way; thence North 14° 30' East along the West line of said right of way 69.50 chains to a point due East of the Northeast corner of said Goff D.L.C.; thence West 40.31 chains to the Northwest corner of the East half of said Goff D.L.C.; thence South 123.37 chains; thence East 33.68 chains to the West line of Samuel Burch Donation Land Claim No. 47; thence North 24.77 chains to the place of beginning. Excepting and reserving the re from the right of way as deduced to the Western Oregon Railroad Co., from the South end of the Derry Depot grounds to where the same leaves above premises 60 feet in width.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
