CERTIFICATE OF WATER RIGHT

This Is to Certify, That BRYCE BARTRUFF

of Route 3, Scio , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Crabtree Creek a tributary of South Santiam River for the purpose of

irrigation under Permit No. 16652 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 2h, 19h5

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.82 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 SN_4^1 and SN_4^1 , Section 7, Township 11 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.6 acres in the NW1 SW1
41.2 acres in the SW2 SW4
1.2 acres in the SE4 SW4
Section 7
1.8 acres in the NE4 NW4
7.8 acres in the NW4 NW4
Section 18
T. 11 S., R. 1 F., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing at the Northwest corner of Section No. 18, in Township No. 11 South, Range No. 1 East of the Willamette Meridian, Oregon, and running thence South 11 rods; thence East 160 rods, to the East line of the Northwest quarter of said section No. 18; thence North 91 rods, more or less, to the Northeast corner of the S.E. quarter of the S. W. quarter of Section No. 7, in said Township and Range; thence West 80 rods, more or less to the Northeast Corner of the Southwest quarter of the Southwest quarter of said Section No. 7; thence in a Northwest direction to the Northwest corner of the Northwest quarter of the Southwest quarter of said Section No. 7, and thence South 160 rods, more or less, to the place of beginning, and containing in the aggregate 111 acres, more or less, all lying and being situate in the County of Linn and State of Oregon, excepting therefrom 2.21 acres conveyed to Lee Gaines and Bessie M. Gaines by deed recorded on page 230, Book 16h of the Deed Records of Linn County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
