CERTIFICATE OF WATER RIGHT

This Is to Certify, That CARL SCHMID

of Route 3, Box 167, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Drift Creek

a tributary of Pudding River for the purpose of irrigation

under Permit No. 16933 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.107 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Thos. J. Wilcox D.L.C., Section 8, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.1 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Thos. J. Wilcox D. L. C.
2.5 acres in Lot 3 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), as projected on Thos. J. Wilcox D. L. C.
Section 8
T. 7 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing at the re-entrant corner on the South boundary line of the Donation Land Claim of Thomas J. Wilcox and wife in Township 7 S. R. 1 W. of the Willamette Meridian, the same being also the N.W. Corner of the Donation Land Claim of Joseph M. Blackerby and wife; thence South 12.56 chains; thence West 39.66 chains to a point in the East boundary of the Donation Land Claim of Thomas C. Shaw and wife; thence North on last said claim line 12.56 chains; thence East 39.66 chains to the beginning and containing 50 acres of land more or less the same being a part of the Donation Land Claim of Thomas J. Wilcox and wife and situated in Marion County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
