## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That B. A. LYDAY

of Route 1. Monmouth , State of Oregon, of a right to the use of the waters of

Luckiamute River a tributary of Willamette River

for the purpose of

inder Permit No. 17079 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

May 11, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.038 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW1 NW1, as projected on Sebastian P. Ritner D.L.C. No. 58, Section 9, Township 10 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.4 acre in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Sebastian P. Ritner D.L.C. No. 58 Section 4
- 0.7 acre in the  $SE_4^1$   $SE_4^1$ , as projected on Sebastian P. Ritner D.L.C. No. 58 Section 5
- 1.3 acres in the NE 1/4, as projected on Sebastian P. Ritner D.L.C. No. 58 Section 8
- 0.6 acre in the NW4 NW4, as projected on Sebastian P. Ritner D.L.C. No. 58
  Section 9
  T. 10 S., R. 6 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 16 chains east from the southwest corner of the Donation Land Claim of Sebastian Ritner, Notification No. 5147, Claim No. 58 in Township 10 South of Range 6 West of the Willamette Meridian, in Polk County, Oregon, and running thence North 20° West 11.86 chains; thence North 70° 30' East 6.82 chains to the center of the Luckiamute River; thence South 2° 40' West up the center of said River 13.44 chains; and thence West 1.75 chains to the place of beginning, and containing 5.22 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
