CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. J. DIETZ

of 2855 North River Road, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River irrigation

for the purpose of

under Permit No. 17174 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 30, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.011 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE_4^+ NE_4^-), Section 15, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

T. 7 S., R. 3 W., W. M.

3.3 acres in Lot 1 (NE4 NE4) Section 15

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 9.12 chains South and 51.56 chains West from the Southeast corner of the Donation Land Claim of T. D. Keizer and wife in Township 7 South Range 3 West of the Willamette Meridian in Marion County, State of Oregon; said point being the Northwest corner of land now owned and occupied as a poor farm by Marion County, Oregon, and being in the middle of the County Road leading from Salem, Oregon, to Wheatland, Oregon; thence North 27° East 5.608 chains along said County Road; thence North 89° West 11.30 chains to the Bank of the Willamette River; thence South 2° 10' West 1.73 chains along the Bank of said River; thence South 9° 37' East 3.50 chains along the Bank of said River; thence East 8.23 chains to the place of beginning, and containing 5.00 acres of land.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
