**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** RUSSELL THOMAS

of Crawfordsville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Brush Creek a tributary of Willamette River for the purpose of irrigation

under Permit No. 17274 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 13, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{2}$ , as projected on Thomas S. Woodfin D.L.C. No. 43, Section 29, Township 14 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.8 acres in the NE $\frac{1}{4}$  NE $\frac{1}{2}$ , as projected on Thomas S. Woodfin D.L.C. No. 43
- 8.2 acres in the NW $\frac{1}{4}$  NE $\frac{1}{2}$ , as projected on Thomas S. Woodfin D.L.C. No. 43
- 2.0 acres in the SW $\frac{1}{4}$  NE $\frac{1}{2}$ , as projected on Thomas S. Woodfin D.L.C. No. 43

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning 20 chs. Westerly from the SE cor. and on S line of the DLC of Thos. S. Woodfin, Claim 43, in Tp. 14 S R 1 W, thence Southerly (Westerly) on the S line of said claim, 24.88 chs., thence Northerly parallel with the E line of said Claim, 20 chs., thence Easterly parallel with the S line of said Claim 24.88 chs., thence Southerly parallel with the E line of said Claim 20 chs. to beginning containing 50 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
