## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That HERMAN BATE

of Willamina , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Willamina Creek, tributary of South Yamhill River for the purpose of

under Permit No. 17782 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 3, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NE\frac{1}{4}$   $NE\frac{1}{4}$ , as projected on Jermiah Lamson D.L.C. No. 46, Section 35, Township 5 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the NE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, as projected on H. H. Simms D.L.C. No. 40 2.0 acres in the NE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, as projected on Jermiah Lamson D.L.C. No. 46 Section 35

T. 5 S., R. 7 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Tracts numbered 11 and 58 of Corbett Acreage as shown by the recorded map and plat thereof in the office of the County Clerk and recorder of Yamhill County, Oregon. Save and except a tract out of the Northeast corner of Lot 11, heretofore sold to A. M. Shandy. Also save and except the following described premises, to-wit: Beginning at the Southwest corner of Lot 58 in the Corbett Acreage T. 5 S., R. 7 W. of the Willamette Meridian in Yamhill County, Oregon, thence North 110 feet along the west boundary line of said lot 58; thence East 202 feet; thence south 200 feet; thence West 187 feet; thence South 210 feet to the North boundary of county road; thence West 15 feet to point of beginning, containing one (1) acre more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
