CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALBERT G. MIKKELSON

of Silverton, State of Oregon ⁹⁷³⁸¹, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Silver Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 17759 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 21, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 32, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

23.5 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$
13.7 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$
0.3 acre in the NE $\frac{1}{4}$ SE $\frac{1}{4}$
3.5 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing on the North and South legal subdivision line and near the middle of the County Road leading from Silverton to Salem at a point which is 17.24 chains South and 10.12 chains East from the quarter section corner between Sections 29 and 32 in Township Six (6) South, Range One (1) West of the Willamette Meridian in Marion County, Oregon; thence South along said division line, 26.76 chains to a point 4.00 chains South of a line dividing said Section 32 into North and South halves; thence East 30.00 chains, more or less, to the East line of said Gideon S. Cox and wife Donation Land Claim; thence North on said East boundary line, 17.33 chains; thence West 26.66 chains; thence North on the line dividing said Donation Land Claim into East and West halves 10.15 chains to the County Road aforesaid; thence South 78° West 3.54 chains to the place of beginning and being in Marion County, Oregon. Save and except roads.

Also: Beginning at a point that is 26.67 chains South, and West 26.67 chains from the Northeast corner of Section 32 in Township 6 South, Range 1 West of the Willamette Meridian, Marion County, Oregon, said beginning being the Southwest corner of 34.32 acres conveyed to W. A. Gatchet by deed recorded May 29, 1920 in Vol. 157, Page 73, Deed Records, said beginning point being also the reentrant corner in the 55.02 acres conveyed to Richard Miles Harding and Elizabeth Harding, his wife, by deed recorded November 5, 1902 in Vol. 79, Page 540, Deed Records; thence North 5° 30' East along the West line of said Gatchet tract, 11.25 chains to the County Road; thence South 78° West along said road to the Northeast corner of said Harding land.

thence South along the East line of said Harding land to the place of beginning; and being a part of the Gideon S. Cox Donation Land Claim in Section 32, Township 6 South, Range 1 West of the Willamette Meridian in Marion County, Oregon. Except roads.
