CERTIFICATE OF WATER RIGHT

This Is to Certify, That O. A. JORGENSON

of Route 1, Jefferson, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Santiam River Slough a tributary of Willamette River for the purpose of irrigation under Permit No. 17827 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 5, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.088 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Reason Roby D.L.C. No. 48, Section 29, Township 9 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.7 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Reason Roby D.L.C. No. 48
- 4.1 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Reason Roby D.L.C. No. 48

- 0.3 acre in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Reason Roby D.L.C. No. 48
- 0.9 acre in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Reason Roby D.L.C. No. 48

T. 9 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the northwest corner of a certain 9.83 acre tract upon which JOHN MYERS, et al, has executed a contract of sale to FRED H. JORGENSEN under date of October 25, 1919, said corner being 25.99 chains north and 24.14 chains east of the southwest corner of the donation land claim of REASON ROBY in township 9 south, range 3 west of the Willamette Meridian, and running thence north 9.50 chains to a point in the south line of the county road leading to JEFFERSON; thence south 82° 14' east 5.38 chains along the south line of said road; thence north 80° east 14 links; thence south 8.80 chains to said Jorgensen's north line; thence west along said north line 5.47 chains to the place of beginning, and containing 5 acres of land, more or less, in Marion County, Oregon.

Beginning at a point 29.61 chains East, and 27.82 chains North of the Southwest corner of the Donation Land Claim of Reason Roby, in Township 9 South, Range 3 West of the Willamette Meridian, in Marion County, Oregon; and running thence North 6.97 chains, to the South line of the County Road leading from Talbot to Jefferson; thence North 80° East, along the South line of said Road 2.77 chains; thence South 7.54 chains; thence West 2.73 chains to the place of beginning; containing two (2) acres of land, more or less, situated in said Reason Roby Donation Land Claim, in Township 9 South, Range 3 West of the Willamette Meridian, in Marion County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
