CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALONZO AND HELEN VAUGHN

of Route 1, Carlton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream formed by springs of M. Yamhill River a tributary of Russel Creek, Tributary of Panther Creek, tributary/ for the purpose of irrigation and domestic use for one family under Permit No. 17880 of the State Engineer, and that said right to the use of said waters

has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 13, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.023 cubic foot per second, being 0.01 cubic foot per second for domestic and 0.013 cubic foot per second for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, as projected on Daniel Simmons D.L.C. No. 54, Section 16, Township 3 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{7}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.1 acres and domestic in the $SE_{\frac{1}{4}}^{\frac{1}{4}}$, as projected on Daniel Simmons D.L.C. No.54 Section 16

T. 3 S., R. 5 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Legal Description of 20 ac is as follows from County Deeds Vol 136 P 876 Yamhill Co. $N\frac{1}{2}$ of $SE^{\frac{1}{4}}$ of $SW^{\frac{1}{4}}$ of Sec. 16; T. 3 S: R 5 W: W. M. together with that certain Right of Way described in Vol 126 page h^{γ} of Deeds of Yamhill County.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
