CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILEY M. GARDNER

of Route 2, Box 118, Dallas , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Little Luckiamute River and Teal Creek, tributary of Little Luckiamute River, a tributary of Luckiamute River for the purpose of

irrigation
under Permit No. 13595 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 18, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4^1 , SW_4^1 , Section 25 and S_2^1 , SE_4^1 , Section 26, as projected on Samuel J. Gardner D.L.C. No. 42, Township 8 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 8.7 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Samuel J. Gardner D.L.C. No. 42 Section 25
- 10.7 acres in the $SW_{\frac{1}{4}}^{\frac{1}{2}}SE_{\frac{1}{4}}^{\frac{1}{4}}$, as projected on Samuel J. Gardner D.L.C. No. 42 7.3 acres in the $SE_{\frac{1}{4}}^{\frac{1}{4}}SE_{\frac{1}{4}}^{\frac{1}{4}}$, as projected on Samuel J. Gardner D.L.C. No. 42

 6.3 acres in the NE4 NE4, as projected on Samuel J. Gardner D.L.C. No. 42
 Section 35
- 7.0 acres in the NW1 NW1, as projected on Samuel J. Gardner D.L.C. No. h2
 Section 36
 T. 8 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
