CERTIFICATE OF WATER RIGHT

This Is to Certify, That ELIZABETH M. TROWBRIDGE

of Route 1, Box 398, West Linn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 17599 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from March 11, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.007 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWZ SWZ, Section 21, Township 2 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in Lots 66, 10 and W2 of Lot 9 of Mossy Brae Subdivision being within NW2 SW2 Section 21
T. 2 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: The West one half of Lot Nine (9) to be cut off by a line parallel with the line between lots 9 and 10; all of Lots Ten (10) and Sixty six (66) and part of Lot "A" MOSSY BRAE, according to the duly recorded plat thereof, described as: Commencing at the southwesterly corner of Lot Ten (10) of Mossy Brae and running thence northerly and along the westerly line of said lot ten (10) and the extension thereof in a straight line northerly to the southerly line of River Road; thence tracing the southerly line of River Road and the northerly line of Lot 66 of Mossy Brae to the northeasterly corner of said Lot 66; thence southerly and tracing the easterly line of Lot 66, to its southerly in a straight line across lot "A" of Mossy Brae to an iron pipe which is located on the northerly line of Lot 9 of Mossy Brae and which iron pipe is 31 feet distant in a straight line from the northwesterly corner of said Lot 9; thence southerly and parallel with and 31 feet distant in an easterly direction from the westerly line of said lot 9, to an iron pipe set in the southerly line of said lot 9; thence westerly and along the southerly boundary line of lots 9 and 10 aforesaid a distance of 93 feet, to the place of beginning Situate in Clackamas County, State of OregonThe right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
