a tributary of Molalla River

for the purpose of

irrigation
under Permit No. 18151 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from February 19, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.025 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_4^1 SE_4^1 , Section 27, Township 4 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the NE¹/₄ SE¹/₄ Section 27 T. 4 S., R. 2 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: A part of the East Half of the Southeast quarter of Sec. 27 T. 4 S., R. 2 E. of W. M. described as beginning at an Iron Pipe driven in the south boundry line of said Sec. 27 at a point S. 89° 51' E. 232.3 Feet distance from the South West Corner of the SE_4^1 of the S. E_4^1 of said Sec. 27 running thence North 2276.85 ft. to an Iron Pipe driven in the center of the Wrights bridge and Meadow Brook County road thence along the center line of said road S. 42° 30 ft. E. 395.95 ft. to an Iron Pipe thence South 1985.62 ft. to an Iron Pipe driven in the South Boundry of Sec. 27 aforesaid thence North 89° 51' W. tracing the Sec. line 267.5 ft. to the place of beginning containing 13.10 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
