CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHAUNCY C. AND RACHEL E. GETTMAN

of Route 2, Newberg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Otis Springs Creek a tributary of Willamette River for the purpose of irrigation

under Permit No. 11881 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 7, 1935

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 NE_4^1 , as projected on Luke McKern D.L.C. No. 56, Section 21, Township 3 South, Range 2 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: A part of the North half of the Donation Land Claim of Luke McKern and wife, Notification No. 1480, Claim No. 56, in Township 3 South, of Range 2 West of the Willamette Meridian, in the County of Yamhill, in the State of Oregon, more particularly described as follows, to-wit: Beginning at the Northeast corner of said Donation Land Claim and running thence West 1258.6 feet, thence South 984.5 feet, thence East 152 feet; thence South 630.52 feet, thence East 1106.6 feet, thence North 24.74 chains to the place of beginning, containing 44.463 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
